

# Vacation Cabins

Enjoy nature's beauty from a rustic cabin nestled in the woods. Hanging Rock and Morrow Mountain state parks both offer vacation cabins with two bedrooms, bathroom, living room, kitchen and dining space. They are for family use only. Both parks offer accessible cabins. Maximum capacity is six persons.

**Furnishings and Equipments:** Each cabin is furnished with four single beds, a sleeper sofa or futon, tables, chairs, an electric stove, refrigerator and other necessary furniture. Pillows, blankets, dishes, silverware, glassware and cooking utensils are provided. The Division of Parks and Recreation does not supply beds for children too small to sleep in single beds.

**Rentals:** The cabins are available for rent from March 1 to December 1. Hanging Rock State Park has four cabins available year round excluding periods of severe weather and December 24 and 25. From the first Monday in June through the last full week of August, cabins are rented by the week only. The stay begins on Monday at 4:00 p.m. and ends the following Monday at 10:00 a.m. The weekly rate is \$400. Reservations are limited to a maximum of one week. Swimming privileges are an additional \$20.

From March 1 to the first Monday in June and September 1 until December 1, cabins may be rented by the night with a minimum of two nights. Hanging Rock State Park cabin availability is extended from December 1 to March 1. The nightly rate is \$80. Each family is limited to one rental per calendar year. Rental fees are due in full 30 days in advance of the date on which the reservation begins. Rental fees for reservations made less than 30 days in advance are due at the time the reservation is made. The Division of Parks and Recreation reserves the right to cancel reservations if advance payment is not made. A returned check fee of \$25 will be charged for all returned checks.

**Refunds:** No refund of a paid reservation will be made unless a cancellation request is made at least 30 days prior to the date on which the reservation begins. Money will be refunded with less than 30 days notification only when the cabin is re-rented. There will be a \$5.00 service charge for all refunds.

Note: Cabin reservations and use may be cancelled in the event of severe weather at the park. During such periods refunds will be provided for any unused portion of your stay.

**Damage:** Charges will be made for any broken or missing items and for any damages to furnishings and equipment. A charge will also be made if any unusual or excessive cleaning is required.

**Pets:** Pets are not allowed in the cabin or cabin area at any time.

**Smoking:** Smoking is not allowed in the cabins at any time.

**Reservations:** Reservations will be accepted on a first-come, first-serve basis, except that preference will be given to residents of the state of North Carolina. Reservations will be accepted up to one year in advance of your planned date of stay.

Check or money order should be made payable to the **Treasurer of North Carolina** and mailed to the superintendent of the park you plan to visit. Payment should not be sent until a reservation confirmation notice is received.

Reservations shall not be transferred or assigned without written consent of the park superintendent.

The Division of Parks and Recreation reserves the right to reject any request for reservations not submitted on the required application. Telephone and email reservations are not accepted.
